WHAT TO BRING - REQUIRED DOCUMENTS, IF APPLICABLE.

- If you were a victim of identity Theft, you must bring your **IDENTITY THEFT LETTER** from the IRS with your newly-issued PIN number.
 - Must have current **GOVERNMENT ISSUED ID** with correct information.
 - **SOCIAL SECURITY** card or verification letter that includes **THE SOCIAL SECURITY NUMBER, OR INDIVIDUAL TAXPAYER IDENTIFICATION NUMBER** letter for all members to be included in the tax return.
 - **W-2 FORMS FOR ALL JOBS WORKED (2025,2024,2023,2022...)** as applicable to the tax year you need to file.
 - **FORM 1099-G** for unemployment compensation and state or local tax refunds.
 - **FORM 1099-R** or form **SSA-1099**.
 - If you are **self-employed**:
 - Bring all the supporting documentation related to your business income and expenses. (If you worked with Uber and/or Lyft, you must bring the official statement they provide)
 - Must bring your form **1099-NEC, 1099-K**.
 - If filing a married joint return: **BOTH** spouses must be present during the time of the visit.
 - **FORM W- 2G and any other 1099** form received last year.
 - Childcare provider name, address, and tax ID number (may be the care provider's SSN/ITIN), and the amount paid last year.
 - Other applicable tax-related documents, such as interest statements, federal loan documents, retirement statements, list of organizations to which you made charitable donations, etc.
 - **FORMS 1095-A, B, OR C**, Affordable Health Care Statements.
 - **FORM 1099-K** for those self-employed taxpayers who use debit, credit, other 3rd party (e.g. cash app, venmo, zelle) for business transactions or settled with a third party network for transactions with gross payments that exceed \$600 last year.
 - **DIRECT DEPOSIT INFO:** banking or credit union account information (routing and checking/saving account number) if you would like direct deposit of your refunds.
 - Bring your previous year's tax return depending on which tax return you need help preparing.
- NEW FOR 2025:**
- **Charitable donations:** Even if you take the standard deduction, bring your receipts — you may qualify for up to \$1,000 in extra deductions (\$2,000 if married filing jointly).
 - **New vehicle purchase:** If you bought a 2025 model-year vehicle, bring your loan statement showing interest paid, lender name, and VIN.
 - **Income documents:** Bring paystubs showing qualified overtime, plus all W-2s and 1099s.

This is not a complete list of required documents. Tax law changes in 2025 may require you to additional documents.
